# THE REGIONAL SEMINAR ON PARLIAMENTARY ROLES IN PROTECTION OF MARINE ENVIRONMENT AND SUSTAINABLE USE OF MARINE RESOURCES IN THE YELLOW SEA

#### 1. OBJECTIVES

The marine environment in the Yellow Sea areas has been impacted by very strong anthropogenic pressures, such as development in the coastal countries, including rapid population increase, industrialisation, expansion of human habitats, and increased demand for sea food from increased population.

There have been a lot efforts put forth by the Governments of the coastal countries of the Yellow Sea to protect the marine environment and sustainable use of marine and coastal resources. It is widely recognised by the Governments that to reduce the environmental stresses will be a long term tasks of theirs, and will require wider participation of all stakeholders to ensure that their efforts are meaningful and successful.

The Parliament, the National Assembly in Korea, and the National People's Committee in China, are playing important roles in deciding national regulations, national infrastructure and national budget. If their roles are well-recognised and used wisely, the mechanism of involving Parliament members will definitely assist in the protection of marine environment and sustainable use of marine resources. The parliamentary roles are very important in particular, for the preparation and approval of the Strategic Action Programme (SAP) and the National Yellow Sea Action Plans (NYSAPs). Parliamentary participation and involvement can also enhance national co-ordination and regional co-operation.

The objectives of the regional seminar are:

- (i) to enhance stakeholders' participation in the activities of protecting the marine environment and sustainable use of marine and coastal resources, in particular the participation of parliaments in the participating countries;
- (ii) based on the knowledge and information provided in the Transboundary Diagnostic Analysis (TDA) of the YSLME project, to facilitate better understanding of requirements for harmonising national legislation and reform;
- (iii) to identify appropriate mechanisms to ensure and/or enhance integrated management for protection of marine environment, and enhance national coordination of all stakeholders, including governmental agencies; and
- (iv) to assist in mobilising necessary financial support for the integrated management of the marine and coastal resources.

### 2. PARTICIPANTS

The participants of the seminar will include: (i) members of parliament (the National Assembly in Korea, and the National People's Committee in China), who are interested in, and responsible for the protection of marine environment and sustainable use of coastal resources; (ii) scholars in the field of parliamentary roles and participation in environment protection; and (iii) resource persons necessary for the Seminar.
