2. ORGANISATION OF THE MEETING

2.1 Election of Officers

RSTP members will be invited to elect a Chairperson and Vice-Chairperson for the meeting. The Project Management Office (PMO) shall act as secretariat to the RSTP Meeting.

2.2 Documentation Available to the Meeting

The Chairperson will invite the Secretariat to introduce the documents prepared for the meeting, referring to Document UNDP/GEF/YS/RSP.3/inf.1.

2.3 Organisation of Work

The Chairperson will invite the Secretariat to introduce this agenda item, referring to Document UNDP/GEF/YS/RSP.3/inf.3.

The meeting will be conducted in English.

3. ADOPTION OF THE MEETING AGENDA

4. PROJECT MANAGER'S REPORT ON THE IMPLEMENTATION OF PROJECT ACTIVITIES

- (i) Discussions and outcomes of the third RWG meetings, including new findings from the data and information collected. Highlights should include the data and information collection activity and regional synthesis reports for preparing the Transboundary Diagnostic Analysis (TDA) in each group;
- (ii) The finalisation of each component's causal chain analysis;
- (iii) Environmental valuation and governance analysis;
- (iv) NGO participation and status in the PSC;
- (v) Cross component issues on which the RSTP should make a decision; and
- (vi) Project's future workplan.

The meeting will be invited to consider the reports presented by the Chairpersons of the RWGs, discuss the necessary technical issues raised in the reports, and agree on the actions for future project implementation.

The meeting shall also consider the cross component issues raised in the reports, and agree on the necessary actions to address the cross-components issues.

7. REGIONAL GIS AND META DATABASES

The Chairperson will invite the Director of the China-Korea Joint Research Centre to present a proposal on the GIS and Meta databases operation and maintenance, following the establishment of the databases (Document UNDP/GEF/YS/RSP.3/7). The document will be prepared by Dr. Jung, as agreed in the RWG-I meeting.

The meeting will be invited to consider the proposal, and provide technical guidance on the operation and maintenance of the databases, in particular (i) how to co-operate and co-ordinate with other data centres and databases existing in the region; and (ii) how to establish the mirror sites as agreed earlier.

The Consultant hired to prepare the TDA will present the draft TDA (Document UNDP/GEF/YS/TDA Draft2), noting any additional information that might be needed for the final version. It should be noted that due to late completion of national reports, some more information need to be added to the TDA, in particular for the biodiversity and fisheries components.

The meeting will be invited to review the draft TDA, and provide comments for the final version.

9. CO-OPERATIVE CRUISE (WINTER CRUISE)

The Chairperson will invite the Project Manager to report on the preparation of the cooperative cruise (winter cruise), including current status, further discussion and negotiation and necessary arrangements (Document UNDP/GEF/YS/RSP.3/8).

The meeting will be invited to consider the winter cruise, and provide guidance on the technical arrangement of the cruise.
