**2. ORGANISATION OF THE MEETING**

**2.1 Election of Officers**

RSTP members will be invited to elect a Chairperson and Vice-Chairperson for the meeting. The Project Management Office (PMO) shall act as Secretariat.

The Chairperson will invite the Secretariat to introduce the meeting documents, referring to Document UNDP/GEF/YS/RSP.4/inf.1.
