1. INTRODUCTION

This Progress Report covers progress of the project made during the period from January through November 2007.

Following the completion of the TDA (Transboundary Diagnostic Analysis) Report, activities for the 2007, the Third Year of the Project, have mainly been focused on the preparation of the SAP (Strategic Action Programme). A series of meetings have been organized by the Project Management Office (PMO); SAP Consultation Meeting in February, the 1st SAP Ad-Hoc Working Group Meeting in April, 1st Regional Science Conference on the Yellow Sea and 2nd SAP Ad-Hoc Working Group Meetings in August, etc.

Efforts have also been made to fulfill the cooperative study cruise which has been carried over from the last year. With strenuous efforts and coordination by the PMO, an agreement has been reached between two countries to launch a joint winter cruise in next January 2008.

The major activities and outcomes of the project in 2007 are described and listed by months in the report.

It is believed that the Project has been progressed well so far except for the delay of the joint cruise.

2. ACTIVITIES AND RESULTS

A. MEETINGS AND WORKSHOPS

FEBRUARY

* National Working Group Chairs Meeting (1st/2007): 1 February 2007.

To review and discuss the concept of SAP, and agenda items for the SAP Consultation Meeting to be held in Xishuangbanna, China, 6-8 February. Endorsed the participation of four experts from Korea.

Meeting adopted the concept of 'carrying capacity of ecosystem' as the major theme of the SAP, and decided to establish "SAP Ad-Hoc Working Group" for the preparation of SAP.

APRIL

The NPC/ROK has joined in the process along with 11 experts members of the Ad-Hoc Working Group.

The meeting has tentatively identified and reviewed the regional targets for the environmental management actions for the Yellow Sea, and also reviewed the draft programmes of the 1st Regional Science Conference scheduled for 14-16 August 2007.

B. COORDINATION AND ORGANIZATION

i) The Cooperative Study Cruise

The Cooperative Study Cruise has been a major issue in the implementation of YSLME Project in 2007. Coordinations for the cruise map (sampling stations) have been made with the national experts and government officials. Through a series of meetings and discussions between PMO and NPCs of both countries, a tentative agreement on the revised cruise map and the winter cruise schedule has been reached:

Winter Cruise:

- -Survey period: 5-25 January 2008.
- -Number of survey stations: 37 stations.
- -Sharing of samples: all samples will be equally shared both countries
- * Fisheries survey will not be conducted during the winter cruise, but remains as a pending issue for the next cruise.

ii) Data/Information Collection

Efforts have been made to complete the final reports of Data/Information Collection activities for two components, biodiversity and pollution. Among the data/information collection activities for four components (fisheries, ecosystem, pollution, biodiversity), final report for the biodiversity has been considerably delayed as it was submitted to PMO in March 2007. Revision for the pollution report has also been made through April 2007.

iii) Nomination for SAP Ad-Hoc Working Group

NPC, through consultation with NWGs, selected and nominated two experts to PMO as the members of the SAP Working Group:

iv) Evaluation/Nomination of Internship Candidates

NPC evaluated seven Korean applicants for the 2007 Project's Internship, and submitted an evaluation sheet to PMO. As there was no suitable candidate, PMO re-advertised for the Internship. Accordingly, NPC re-evaluated five additional applicants, and nominated Mr. Yunil Kim of Johns Hopkins University, U.S.A. based on the relevance to the project after the internship.

3. ACHIEVEMENTS, DIFFICULTIES, PROBLEMS

a) Initiation of the SAP and NSAP Preparation

The major achievements of the project in 2007 are: Establishment of SAP Ad-Hoc Working Group, finalization of conceptual procedure and structure of the SAP, organization of SAP Drafting Group, preparation of guidelines for NSAP development, etc.

Ten Korean experts have been involved in the process as the members of SAP Ad-Hoc Working Group, and as the consulting experts. For the successful development of the SAP/NSAP, it would be necessary to have more expertises at the national level which would require more financial support from the project, particularly for the preparation of NSAP.

b) Completion of Data/Information Collection and Regional Synthesis

Although there have been a considerable delay in submission of the final reports, the data/information collection have been completed and the TDA report has been finalized based on the collected relevant data. The regional syntheses for project components have also been finished.

c) Identification of Regional Targets and Potential Management Actions

Through the SAP Ad-Hoc Working Group meetings, regional targets (ecosystem quality objectives) and potential management actions have tentatively identified. These will greatly contribute to the preparation of SAP and NSAPs.

d) Agreement on the Cooperative Study Cruise

It is a remarkable progress that an agreement on the Cooperative Study Cruise between two countries has been reached; the winter cruise will be conducted during 5-25 of January 2008 at 37 sampling stations. Yet, it is regrettable that the fisheries stock assessment would not be included in the survey components.

It remains, therefore, to be further discussed for the second cruise (spring or summer) later.

e) Sharing of Data and Samples from the Joint Study Cruise

It is also a noticeable achievement that China and Korea have agreed to equally share all samples and data collected from the joint cruises, even though there has been existed a different of view in two countries on the sharing of samples collected from the joint cruise. The spirit of equal sample sharing could have a very sound impact on the future cooperative studies in the region.

f) Difficulties in Nominating Delegates to the RWG meetings

There still exist difficulties in nominating the delegates to the RWG meetings as many members of the national working groups are not available or unconcerned for the RWG meetings. It is necessary to encourage the scientists by providing them with more opportunities to work in the project through small grant programmes, workshops, symposia, trainings, etc.

Limited number of experts and organizations have been involved in the project so far.

g) More Governments' Involvement Needed

As the SAP and NYSAP will have to be reviewed and endorsed by the governments, it is necessary to have more active and better involvement of them not only during the course of preparation but also review and endorsement processes of the SAP. This matter could be expedited further through the upcoming RSTP and PSC meetings.
