6.1 Discussion on Yellow Sea ecosystem problems, identification of data and information requirements, and agreement on their format

The Secretariat will present a draft table of ecosystem problems, required data and formats, and initial causal chain and governance analyses (Document UNDP/GEF/YS/RWG-E.1/5).

Keeping the requirements for preparing TDA in mind, members will be invited to:

- (i) Identify the regional environmental problems regarding the ecosystem component, identify the necessary supporting data and information available to specifically indicate the levels and extent of these problems;
- (ii) Discuss the transboundary ecosystem-related problems in the Yellow Sea and identify the required data to analyse the transboundary nature of these problems; and
- (iii) Identify the data and information required for causal chain analysis and governance analysis, including the requirements and formats.

<u>Members will be invited to agree upon proposed methods for acquiring data and information to input into the TDA.</u>

6.2 Country presentations on available data/information on state of the ecosystem, data requirements to estimate carrying capacity, causal chain analysis, information gaps for ecosystem stressors

<u>Members will be invited to present the current state of knowledge on available</u> <u>pollutant information, and anything else they feel is relevant to this topic.</u>

7. REQUIRED COSTED ACTIONS AND WORKPLAN

7.1 Required actions for TDA preparation

The Secretariat will be invited to give a presentation on the proposed regional criteria for calculation of costs to obtain the data/information (Document UNDP/GEF/YS/RWG-E.1/6).

Based on the discussion and agreement in Agenda Item 6, members will be invited to discuss the required actions for TDA preparation, in particular the data and information collection procedures.

<u>Members will agree on a list of costed activities to be supported within the</u> <u>framework of the project.</u>

7.2 Information gaps and actions required for the field survey

Considering the availability of the existing data and information for preparing the regional TDA, members will be invited to consider the gaps in data and information, and suggest ways to fill the gaps, including the field survey proposed to and approved by the Project Steering Committee.

The Secretariat will inform the meeting about the outcomes of discussion on the field survey, in particular the operation of research vessel.

In the case where field observation and monitoring are needed, the <u>members are</u> <u>invited to propose a detailed programme, taking into account the available</u> <u>financial resources.</u>
