Members will be invited to review the implementation of the project activities since the last meeting: discuss the reports (document UNDP/GEF/YS/RWG-F.2/5), address issues arising from the data and information collection exercise and agree on the inputs for the final TDA document.

Members will be invited to review the implementation of the project activities since the last meeting; discuss the reports, address issues arising from the data and information collection exercise and agree on the inputs for the final TDA document.

6. CONSIDERATION OF THE COOPERATIVE STUDY CRUISE

The Chairperson will invite the Secretariat to present the outcomes and agreements of the Technical Meeting for the Co-operative Study Cruises (17-18 October 2005) (Document UNDP/GEF/YS/JC.1/3).
