After two years of implementation, the UNDP/GEF Yellow Sea Project completed its first major output, the Transboundary Diagnostic Analysis (TDA), and now is focusing on its second major output, the Regional Strategic Action Programme (SAP) and National Yellow Sea Action Plans.

At the Fourth Regional Working Group – Fisheries (RWG-F) Meeting, members and participants will:

- review the completed and on-going activities under the Fisheries Component from 2006 to 2007;
- review the progress-to-date of the SAP;
- agree on remaining actions to take to finalise the SAP and demonstration sites; and
- discuss and agree on future activities to implement.
